criminal justice.

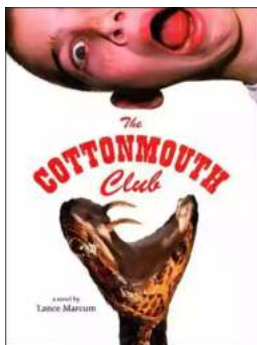

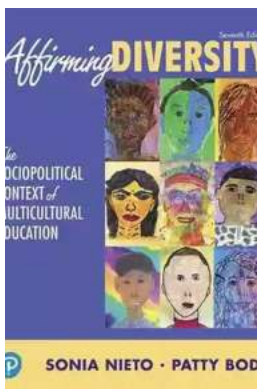
